Principal introduced the new member nominated by JNTUH Dr. B. Ravindra Reddy, Deputy Director, Academic Audit Cell, Professor & Chairman, Board of Studies, Mathematics, JNTUH, Hyderabad. The chairman and members welcomed the new member Dr. B. Ravindra Reddy.

The Chairman requested the Principal to present the agenda points for discussion and necessary action.

1. To confirm and approve the action taken report on the minutes of the 38th Governing Body Meeting held on 12th November, 2022.

The minutes of the meeting and action taken report related to 38^{th} Governing Body are placed before the Governing Body for consideration and approval (Annexure-1) .

The members of the Governing Body approved the same.

2. Academic affairs

Institutional Front:

The Principal presented the complete details regarding the approval of courses for the academic year 2023-24, Intake, Admissions status, Awards, Rankings, Recognitions and Achievements, Collaborations, R-22 Regulations & Curriculum, UG & PG Academic calendars, VEDIC activities during November 2022 to September 2023 to the members.

- The Chairman emphasized the significance of admissions and explained that BVRIT is listed as Top 10 institute in Telangana state with 9th position.
- The principal shared that due to NBA accreditation of seven UG programs, the intake has been increased from 1350 to 1560.
- The Vice Chairman identifies the typographical error in the total admissions and suggested to correct, and principal corrected the same.

- The Chairman appraised the members for TSIC activities such as Intinta Innovators, Palle Srujana and suggested to link the activity details in the institute website.
- The Principal, elaborated on Think & Make program. Intention of this program shall be inked, under this 30 schools are adopted and 70 students of BVRIT completed block 1 training.
- The Vice Chairman enquired on Academic Calendars flexibility to suit for 3.5 & 1.5 program offered under MOU with different universities in USA & Canada. Principal, explained about the academic flexibility.
- Sri V. Rajanna, enquired the institute collaboration with UNB, The Vice Chairman elaborated the UNB collaboration and Co-op program for the alumni for BVRIT.

- Dr. B. Ravindra Reddy, explained the importance of mathematics in engineering and requested to focus on mathematics skills related to AI, ML, Data Science.
- The Vice Chairman elaborated the industry collaborations, Altair & Harita Techserv and Principal appraised that 22 students of EEE, Mech, ECE branches were trained in Centre for Automotive Electronics with support of Haritha Techserve and 22 students are placed and were given offer letters.
- Sri V. Rajanna Suggested to visit VLSI labs at University of Hyderabad.
- The Vice Chairman requested Sri V. Rajanna to provide the *Learning**Platform On Cloud Technologies* for faculty and students.
- Dr. R. K. Agarwal, created the awareness on CSE and Allied branches.
- Sri V. R. Ramakanth, created the awareness on core subjects in CSE Branch and their importance in software industry.
- The Principal explained that R22 Regulations & curriculum The respective BOS of various departments discussed the R22 Regulations and the curriculum. The regulations and curriculum have been approved by BOS and CAC. The same are placed before the Governing Body for consideration and approval.

The members of the Governing Body approved the same.

• The Principal explained that the academic calendars of B.Tech., M.Tech. and MBA for the A.Y 2023-24 are approved in the College Academic council and are presented for consideration and approval by the Governing Body. The members of the Governing Body approved the same.

Students Front:

• Principal presented the final results of the 2019-2023 batch B.Tech. students.

The members of the governing body approved the same.

• Mr. J. Bangarraju, TPO explained that BVRIT records the highest number of unique placements out of the number of eligible students in the state.

The members of the governing body appreciated the efforts of the training and placement cell.

• The Principal explained that Freshmen Induction and Orientation was conducted during 21.08.2023 to 26.08.2023 for the academic year 2023-24.

The members appreciated the same.

Faculty Front:

- Principal explained the faculty recruitment process, retention ratio and the
 details of teaching and non-teaching staff members. He also presented the
 details of faculty publications to all the members.
- Existing Student-Faculty ratio is 1:18. To meet Student-Faculty ratio 1:15,
 68 faculty positions to be sanctioned & recruited, the same is requested for approval by the Governing Body.

All the members appreciated the motivation and encouragement provided by the Institute for faculty upskilling. To ensure effective teaching learning process and also to improve research culture in the Institution the Governing body approved the same for the academic year 2023-24.

3. Research & Development Activities

o Principal presented the Research and development activities to the members. Principal presented the number of publications, patents, sponsored projects and consultancy during 2023.

The members appreciated the same.

4. Infrastructure Development:

The Principal presented and explained the details of infrastructural development carried out in the institution during 2023 and the proposals for improvement in the near future.

The members appreciated and approved the same.

5. Proposed change in student's intake for 2024-25:

New Programs and Strength enhancement in existing Programs:

- **Proposal for New Programs:** B.Tech. CSE (Cyber Security): 60
- Proposal for strength enhancement in existing Programs:
 - o B.Tech. CSE (DS): 120 to 180
 - o B.Tech. AI&DS: 120 to 180
 - o MBA: 60 to 120

Proposal for reduction in intake in existing Programs:

• **B.Tech. ECE:** From 240 to 180 or 120

Merger of the courses: B.Tech CSE and B.Tech IT to form B.Tech CSE

• The members enquired the eligibility and discussed the possibilities of proposing new programs and enhancement of intake in the existing programs. The members expressed that decision has to be taken keeping in view of long term benefits and future scenarios. Further, they suggested to take an appropriate decision by checking the guidelines from JNTUH.

Finally, the members authorized the Chairman of the Governing body to take an appropriate decision following the guidelines of the AICTE and other statutary agencies.

6. Income and Expenditure details for 2021-22

 The principal presented the Audited income and expenditure reports for the financial year 2022-23 & Report of sanctioned budget for the financial year 2023-24 (enclosed in Annexure (VII)) and placed before the Governing Body for consideration and approval.

He explained the support given the student in the form of Tables, Laptops, Internet dongles etc., during the COVID period, Free breakfast, Scholarship of \$ 109,006/- given to the Sai Keerthi Jogannagai of Chemical Engineering, to purse Master's at Columbia university in Fall 2021, free training facilities etc.
- The Principal explained the Research Incentive policy and Industry certifications.
- Dr. B. Ravindra Reddy, suggested to improve the sponsored projects.
- Mrs. G. E. Suhasini congratulated the Principal and the Management for providing all the necessary facilities for the holistic development of the students. She also requested to mentor the government polytechnic colleges.
- Mr. V. Ramakanth congratulated the management and suggested the Principal to highlight the outcomes of the collaborated initiatives and enhance the virtual opportunities.
