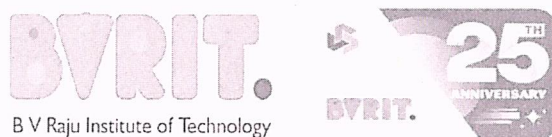

**2. Academic affairs**

**2.1. Institution Front**

**• Admissions:**

Admissions for the academic year 2023-24 were reviewed. UG programs had an intake of 1560 students, with 1549 admissions. PG programs had an intake of 150 students, with 115 admissions.

**• Affiliations & Accreditations:**

- AICTE and JNTUH Affiliation status was detailed.
- NBA reaccreditation for UG and PG programs was detailed.
- NAAC reaccreditation (3rd cycle) secured an A+ grade with a score of 3.37.

**• Awards and Achievements:**

- BVRIT received the **ATF Award 2023** for Assistive Technology initiatives.

- Recognition in **Rehackathon India 2023, Telangana State Energy Conservation Awards 2023**, and hosting of **SAE eBAJA 2K24** were highlighted.
- **Academic Calendars:**

The calendars for AY 2024-25 were presented before the members for approval.
- **Collaborations:**

Partnerships with organizations such as ETS India, Birla Education Trust, and others were noted.

## **2.2. Students Front:**

- Principal presented the final results of the 2019-2023 batch B.Tech. students.
